On March 22, Governor Newsom requested and received a presidential "Major Disaster Declaration," making the economic hardship caused by unemployment due to the Coronavirus Pandemic to be an appropriate target of relief from the NCCRF; and
- 2) At the time you submit this Relief Request Form, you are a member in good standing of a Local Union affiliated with the Carpenters 46 Northern California Counties Conference Board; and
- 3) You have been a member of a Local Union affiliated with the Carpenters 46 Northern California Counties Conference Board for at least 12 consecutive months prior to the Major Disaster Declaration (i.e. you've been a member since March, 2019).
